All Institutions conducting Approved Diploma and Degree course in Pharmacy

Sub.: PCI - Remittance of the Affiliation Fee for 2009-2010 academic session.

Sir

This is to inform that an institution conducting approved Pharmacy Course under the Pharmacy Act, 1948 shall pay an affiliation fee annually as prescribed for Diploma & Degree courses separately to the Pharmacy Council of India by the 30<sup>th</sup> of June every year. The affiliation fee rates are -

- Rs. 15,000/- per annum for D.Pharm course.
- Rs. 15,000/- per annum for B.Pharm course.

The fee should be remitted by account payee's demand draft in favour of Pharmacy Council of India, payable at New Delhi.

While remitting the fee, please intimate the following on your forwarding letter.

1. Name of the course. (Diploma/Degree)
2. Institutions running both diploma & degree courses, shall pay fee through separate demand draft. Please do not submit common demand draft to avoid confusion.
3. Year/Session of affiliation fee;
4. Whether the course for which the fee is being paid, is an approved or unapproved course.
5. File No. of your Institution. For file No. please refer to any of Council's communication sent to you separately regarding approval of your course, it is on top left hand side.


Please treat this letter as a bill for the purpose and also note that the payment of this fee does not mean automatic approval for the conduct of the course at your institution.

Kindly expedite due remittance of the affiliation fee together with the arrears, if any, due for the previous years.

It may please be noted that it is the responsibility of the concerned institutions to remit the due fee in time and no action will be taken by the Council regarding consideration of approval in the absence of affiliation fee.
